4a (Code: ) (Expenses \$ 763,163. including grants of \$ ) (Revenue \$ 185,792. ) The Literacy Americorps: Recruits, trains and supervises recent college graduates from across the United States to spend a year tutoring, mentoring, and teaching in Palm Beach County. - 309 adult learners were assisted with reading, English and employability skills. - 1,239 at-risk youth were coached, tutored and mentored for academic success. - 199 children received tutoring and literacy enrichment to improve reading skills. - 124 children and youth were provided with homework help.

4b (Code: ) (Expenses \$ 407,394. including grants of \$ ) (Revenue \$ ) Reach Out and Read: Partners with medical providers to bring early literacy into the pediatric examination room. The pediatricians and nurse practitioners advise the parents about the importance of reading with their children and give books to the families from the birth to five-year well-child checkups. - 54,461 books were distributed at well child checkups by 103 practitioners at 39 clinics.

4c (Code: ) (Expenses \$ 387,393. including grants of \$ ) (Revenue \$ ) The Glades Family Education Program: Provides comprehensive literacy training for adults and their preschool children in the rural western communities of Palm Beach County. The program served a total of 71 adults and 18 children. - 86% of adult students who were pre and post tested, made significant gains in one or more tested skills (reading, listening and speaking). - 100% of the preschool aged children from the program demonstrated improvement in their language, cognitive and early reading skills.
