

Distribution of funds is based on the decision of the Allocation Committee, a trained group of more than 100 volunteers knowledgeable about community needs. Teams of volunteers spend a cumulative total of 3,000 hours reviewing each agency's finances, programs, outcomes, facilities and long-range plan within the broad framework of community needs; and after a thorough analysis these volunteers recommend how much grant funding each agency program should receive.
