Partner Agency Funding

The Town of Palm Beach United Way's annual citizen review process ensures that our partner agencies meet fiscal acuity standards and that our agencies are held accountable. The distribution of funds is based on the decision of the Allocation Committee, a trained group of 130 volunteers knowledgeable about community needs. Teams of volunteers spend a cumulative total of over 3,500 hours reviewing each agency's finances, programs, outcomes, facilities, and long-range plan within the broad framework of community needs. After a thorough analysis, these volunteers recommend grant funding to the Board for approval.
